EXPOSURE STANDARDS: No exposure limit has been assigned to this product. Where no specific exposure standard has been assigned, the recommended exposure level for dust in general shall be 10mg/m₃ measured as inspirable dust. The exposure limit is expressed as a time weighted average (TWA) concentration over an eight hour working shift, for a 5 day working week, and is the limit recommended by the supplier of this material.

ENGINEERING CONTROLS: No special ventilation is required.

STORAGE AND TRANSPORT: Not classified as dangerous goods. Store in a cool place. Store apart from combustible materials, herbicides and fungicides.
